Responding to increased demand by employers and recruiters for access to highly qualified property managers, we unveiled the BOMA SF CareerCenter in late February. This interactive job board – found at http://careers.bomasf.org enables employers and recruiters to reach a wide range of commercial real estate management candidates.

Our new BOMA SF CareerCenter replaces our previous job bank, providing expanded capabilities for both employers and job seekers. Employers can now quickly and easily access qualified job candidates – including BOMA SF members – through online job postings, statistical analysis and reporting on job activity, résumé search functions, and the

use of search agents that notify them when new candidates who match their

criteria have posted their résumés. Job seekers benefit from free and confidential résumé posting, weekly, automated email notification of new job listings, the ability to save jobs for later review and related career development services.







Giants - Zero; BOMA SF - HOMERUN!!





Brings Commercial Real Estate Issues to Capitol Hill


elegates from across the country went to Washington, DC March 12-13 to visit with our Federal representatives and to carry a message that the commercial real estate industry needs attention on a number of issues. **Ken Cleaveland, BOMA San Francisco's Director of Government and Public Affairs,** along with **Michael Oddo, Metro Maintenance**, visited the offices of Speaker Pelosi, Representatives Woolsey, Lantos, Lee, Tauscher, and Senators Boxer and Feinstein. Top issues that were discussed included:

- Extension of the 15% leasehold improvements depreciation schedule
- Extension of the Terrorism Risk Insurance Act (TRIA)
- Extension and enhancement of the energy tax credits law for Commercial Buildings
- Creation of Federal Risk Insurance Coverage for catastrophic natural disasters such as earthquakes, hurricanes, floods, etc.
- Reform of the Alternative Minimum Tax (AMT) Codes

Technology/IT Tips for Property Management Professionals by Steve Boullianne IPSOFACTO, IT Services

Part 2 of a 6-part series in 2007

Business Continuity & IT

Keeping the doors open, ready to serve clients or customers, is a timeless mandate in the business world. Continuity is essential for maximum ROI and brand acceptance.

Imagine the repercussions when a property management team is brought to a dead halt as work orders, contracts, and e-mail vanish in a flash. Until data is recovered or reconstructed, computer-based transactions cease. And while the doors are closed on a primary set of management tools, a prospective tenant may decide to go elsewhere.

In today's technology-driven marketplace, IT is charged with operational readiness and "Plan B" thinking to reduce downtime. Events like Katrina, Loma Prieta and 9/11 serve as sobering reminders about what can happen without backup. Large property management headquarters typically invest in costly continuity plans, listing step-by-step instructions for restoring systems if disaster strikes.

Continuity for Small Property Management Offices Fortunately, more economical contingency planning can be highly effective for smaller offices. Many of our property management clients have offices with five or fewer computers, and we have completed several small office continuity installations for under \$500. For example, here's a summary of solutions for a BOMA member building, Convention Plaza, managed by Cushman & Wakefield:

• Safeguarding E-mail, Contacts, Calendar & Tasks We secured e-mail, contacts, calendar and tasks for the Convention Plaza team by hosting Exchange/Outlook accounts for Bettie, Margie and Mike on our off-site servers. If an on-site computer crashes, their e-mail is safe and available by web at

home or traveling, anywhere or anytime. Accounts are easy to restore from any location. Meanwhile, host-based filters block spam and viruses.

• Securing System/OS Files, Applications and Data Since Convention Plaza has no server, we created a peer-to-peer network, placing shared files and folders on Bettie's workstation. As a Symantec vendor, we installed one of their "clone" backups for full system protection. Cloning imprints all system data on the hard disk — applications, updates, password and encrypted files. If a workstation with a reliable clone system crashes, we can often restore functions and data within one hour.

Updating PDA's

Off-site hosting also facilitates seamless connections for all Outlook facets. When Bettie changes a phone number in contacts on her computer, the change will immediately sync with her Blackberry. She stays connected, updated and ready for business, even if her computer is not available.

• Ongoing Anti-Virus Protection

Offices or networks of any size are vulnerable to viruses that infiltrate computers via downloaded files. But anti-spyware and anti-virus programs are typically purchased with a credit card by downloading, and recurring fees are charged without notice. Because some small clients are not comfortable with this arrangement, they sacrifice necessary protection. The solution? They can ask their IT partner to make the purchase and invoice them for the charges.
